Once a down payment is received an invoice will be given to you with remaining balance. It is up to the client to inform

NMG of any and all changes to wedding dates, times, locations, etc. A copy of the itinerary must be given to NMG within 3 days before the wedding. No verbal changes will be accepted only written.

If the option of getting a personal wedding website is accepted, the color palette of the website will be designed by our team in accordance to the color scheme of the wedding. All information about the couple, wedding, and necessary parties needs to be given to NMG before the wedding to start website design. Once site design is accepted, the process of finishing the site will transpire. Once site has been approved only minor changes can be made within 7 days after the website is uploaded i.e. text, picture changes. The client will have full ownership of the site, with NMG paying for the first year of upload to our hosting company. Thereafter if it is desired for website to remain published on the web, a fee of \$95 is due once a year via credit card or check. A copy of the website (once completed) will be given to the client in file format to be viewed offline and as an archive once you no longer desire for site to be on the web.
